All the above points offer bunker and/or silo bag storage facilities with the necessary equipment in place to ensure all-weather out-loading at a minimum rate of 90tons per hour or 810 tons over a 9 hour working day. We have also received independent inspection reports confirming the additional points meet the criteria as defined in the contract specifications. The storage operator has also provided the necessary details to support the all weather out loading requirement and acknowledged all obligations as per the JSE agricultural contract specifications.

You will notice that the names of these delivery points have been changed from bunkers to depots. This change was necessary so that we are consistent with the naming convention adopted by Electronic Silo Certificates (ESC) for these depots.
