Changes to the <u>Last Notice Day</u> and <u>Last Delivery Day</u> for all agricultural contracts

Earlier this year the Agricultural Advisory Committee supported bringing forward last notice day to the business day following last trading day. This would assist long position holders who are waiting for delivery by reducing the potential waiting period by 3 business days. By changing last notice day this then implies last delivery day will also move earlier for the delivery month since physical deliveries would continue to be processed on a T+1 basis. No other changes would be made to the trading calendar.

The JSE will be introducing this change to take effect as from the **Dec14 expiry month**. This therefore results in the following changes to the trading calendar for the main hedging months:
