Reference Price	The arithmetic average of the Share price observed every 60 seconds (100 observations), between 12:01pm and 13:40pm. For the avoidance of doubt, this is the same method as the one utilized for the expiry of index stock options on standard quarterly SAFEX expiry dates.
Automatic Exercise	Applicable.
Cash Settlement	Applicable. If the Strike Price Differential is greater than zero, the Short Party shall pay the Long Party the Option Cash Settlement Amount for the number of Options held at the Expiration and Valuation Date.
Option Cash Settlement Amount	Means an amount equal to the number of Options exercised on the Expiration and Valuation Date multiplied by the Strike Price Differential, multiplied by the Multiplier.
Strike Price Differential	<p>For Option 1:</p> <p>Means an amount equal to the greater of:</p> <p>a) $3 \times (\text{Strike Price} - \text{Reference Price})$; and</p>

	<p>b) zero</p> <p>For Option 2: Means an amount equal to the greater of:</p> <p>a) 3 x (Reference Price – Strike Price); and b) zero.</p> <p>For Option 3: Means an amount equal to the greater of:</p> <p>a) 1 x (Strike Price – Reference Price); and b) zero.</p> <p>For Option 4: Means an amount equal to the greater of:</p> <p>a) 1 x (Reference Price – Strike Price); and b) zero.</p>
