New Can-Do Option XF3Q – Knock-Out Barrier Option

The following new Can-Do Option (XF3Q) has been added to the list with immediate effect and will be available for trading on 3rd August 2012. Insofar as any contractual provision set out below is inconsistent with the rules and regulations (“Rules”) of the JSE Limited (“JSE”), the Rules will prevail unless the JSE expressly permits the Parties to give effect to their contractual provisions.

Knock-Out Event	<p>Applicable. Means, in respect of the Index, if at any Knock-Out Valuation Time during a Knock-Out Determination Day, the level of the Index (as published by the Exchange) is equal to or lower than the Knock-Out Price.</p> <p>If a Knock-Out Event occurs, the Option Transaction will terminate, all option contracts will be closed out on the JSE at zero value and initial margin will be returned to the Buyer and the Seller.</p>

PROCEDURE FOR EXERCISE	
Expiration and Valuation Date	20 th June 2013
Expiration and Valuation Time	13:40 on the Expiration and Valuation Date
Reference Price	The arithmetic average of the Index level observed every 60 (sixty) seconds (100 observations), between 12:01 and 13:40. For the avoidance of doubt, this is the same method as the one utilised for the expiry of standard index options on standard quarterly SAFEX expiry dates.
Automatic Exercise	Applicable
Cash Settlement	Applicable. If the Strike Price Differential is greater than zero, the Short Party shall pay the Long Party the Option Cash Settlement Amount for the number of Options held at the Expiration and Valuation Date.

Option Cash Settlement Amount	Means an amount equal to the number of Options exercised on the Expiration and Valuation Date multiplied by the Strike Price Differential, multiplied by the Multiplier.
Strike Price Differential	Means an amount equal to the greater of: a) the Strike Price minus the Reference Price; and b) zero.
