New Can-Do Option XC8Q – Knock-Out Barrier Option

The following new Can-Do Option (XC8Q) has been added to the list with immediate effect and will be available today. Insofar as any contractual provision set out below is inconsistent with the rules and regulations (“Rules”) of the JSE Limited (“JSE”), the Rules will prevail unless the JSE expressly permits the Parties to give effect to their contractual provisions.
