### Safex silo receipts reported lost

Please note that the following Safex silo receipts have been reported lost by a client whilst the receipt was on route with a courier service to their offices and will therefore be cancelled with immediate effect:

To further assist the market, the exchange will record on its webpage, a list of all Safex silo receipts reported lost. The exchange does not guarantee the accuracy of the cancelled receipts published on the webpage since silo operators will be responsible for informing the JSE of any such incidents.

This again is a good example of the risks associated with dealing in paper silo receipts. The market is encouraged where the silo operators are registered with ESC to make use of the electronic silo receipt system. Members are also kindly requested to ensure clients registered with them are linked via Nutron to avoid the unnecessary converting of electronic receipts to paper simply because the ESC account number was not linked.
